

# Declaration regarding Access to UBS AssetLink

The Attorney hereby declares that, for the purpose of his/her activities, he/she would like to use the UBS AssetLink services offered by UBS Switzerland AG (hereinafter UBS). For that purpose, the Principal authorised the Attorney with separate "UBS AssetLink Power of Attorney" (hereinafter the "Power of Attorney") to subscribe for UBS AssetLink and to perform all related rights of use. The Power of Attorney forms an integral part of this Declaration.

With UBS AssetLink, the identification process is not based on signature verification by UBS; instead, the user (i.e. in the present case the Attorney and/or other users appointed by him/her, in accordance with the Power of Attorney [hereinafter the "Users"]) establishes his/her identity vis-à-vis UBS by means of a user ID, a password and a challenge response test (CRT), as set out in the "Terms and Conditions for the Use of UBS AssetLink" (hereinafter referred to as the "Special Provisions"). The Attorney hereby agrees to and acknowledges the user identification procedures outlined in the Special Provisions and in the "Basic provisions for UBS Digital Banking" (hereinafter referred to as the "Basic Conditions").

By virtue of this Declaration, the Attorney gains access via the UBS AssetLink interface to all present and future accounts/custody accounts under the above mentioned master number for which a Power of Attorney has been given in the Attorney's favour. The Attorney may exclude access to certain accounts/custody accounts by expressly informing UBS to that effect in writing.

The Attorney hereby expressly acknowledges that when data is processed in a given country, the laws and regulations of the

country or countries in which such data is processed or to which it is transferred shall apply in addition to the legal provisions of the country in which the relevant accounts/custody accounts, for which the Attorney is permitted to use the services specified in this agreement, are kept. This fact may limit the services of UBS in one or more countries.

The fee to be paid for the use of individual UBS AssetLink services by the Attorney and/or the appointed Users will be agreed separately and debited to the following account of the Principal held with UBS:

If this Declaration is terminated, the fee will be charged pro rata temporis.

The Attorney acknowledges the "Special Provisions" and the "Basic Conditions" as an integral part of this Declaration (in addition to UBS Switzerland AG's "General Terms and Conditions", the "General Terms and Conditions governing Custody Accounts" and the "General Terms and Conditions governing Metal Accounts"). He/she confirm(s) having received and read a copy of these documents.

This declaration shall be governed by and construed in accordance with substantive Swiss law.

Subject to mandatory jurisdictions provided by law the exclusive place of jurisdiction for all legal proceedings shall be Zurich or the location of the branch holding the account.

This shall also be the place of performance, and the place of debt collection for clients domiciled abroad.
